M/T Saunders Craine #1761, of the Louisiana State Police, Bureau of Investigations, assigned to the New Orleans FBI Violent Crime Task Force, who, having been by me duly sworn, did depose and say: That one Robert Durst W/M DOB:

did willfully, knowingly and intentionally violate L.R.S. 14:95.1 Relative to possession of a firearm by a person convicted of certain felonies. L.R.S. 14:95(E) Relative to possession of a firearm in the presence of a controlled dangerous substance.

On Saturday, March 14, 2015, Members of the New Orleans FBI Violent Crimes Task Force (NOVCTF) located Robert Durst at 614 Canal Street in the lobby of the JW Marriott. Mr. Durst had an outstanding arrest warrant issued for his arrest out of Los Angeles County California for 1st Degree Murder. Your Affiant booked Mr. Durst, as a fugitive from Los Angeles County, in Orleans Parish Prison.

Subsequent to Mr. Durst's arrest, Los Angeles Police Department (LAPD) Detective Michael Whelan # 24961 applied for a search warrant on Sunday March 15, 2015, with the assistance of New Orleans District Attorney's Office Investigator Jim O'Hern, for Mr. Durst's hotel room. New Orleans Criminal District Court Magistrate Jonathan Freeman endorsed the search warrant with his signature.

The subsequent search of Mr. Durst's hotel room revealed a Smith and Wesson .38 caliber revolver and approximately 146.96 grams of Marijuana.

Mr. Durst's has prior convictions for violation of Title 18, United States Code, Section 922(g) (2) an individual who is a fugitive from justice and in violation of Title 18, United States Code, Section 922(n) interstate shipment or transportation of a firearm by a person under indictment for a felony.
